

PURCHASE CONTRACT AGREEMENT #549ZO6

CONTRACT DATE: JUL 29, 2026

This Purchase Contract Agreement dated Jul 29 2026, is made and entered into by and between:

Robert Gamber (the Owner),

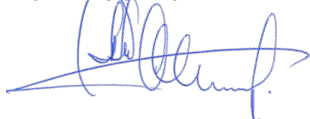
George Dyke (the Purchaser),

Sure Way Inc (the Trusted Trade Agent),

Concurrently with the execution of this Agreement, the Owner and the Purchaser have entered into a Vehicle Purchase and Transportation Agreement dated **Jul 29 2026**, concerning the purchase, and delivery of the following vehicle: **1973 Peugeot 504 Coupé Pininfarina**, Vehicle Identification Number (VIN) **504C121492980** (the "Vehicle"), for a total purchase price of **USD 17,000.00**, with transportation services to be provided by Sure Way Inc, which is incorporated herein by reference. Accordingly, the parties agree as follows:

- 1. Pre-Delivery Verification:** Prior to transportation and delivery, the Seller shall provide the Vehicle for inspection and verification to confirm that the Vehicle corresponds with the specifications, condition, and representations set forth in this Agreement.
- 2. Initial Deposit:** Upon signing this Agreement, the Purchaser shall pay an initial deposit of **USD 17,000.00** by bank transfer. Once the deposit has been received, Sure Way Inc will begin arranging the transportation and delivery of the Vehicle. The deposit will be credited toward the total purchase price of the Vehicle.
- 3. Delivery and Inspection Rights:** Following delivery, the Purchaser shall be granted a period of three (3) business days to inspect the Vehicle and determine whether the Vehicle conforms substantially to the terms and representations contained herein.
- 4. Acceptance of Vehicle:** The Purchaser shall be deemed to have accepted the Vehicle upon providing written confirmation of acceptance or upon expiration of the three (3) business day inspection period without written notice of rejection.
- 5. Rejection and Refund Procedure:** In the event the Purchaser determines that the Vehicle materially fails to conform to the terms of this Agreement, the Purchaser may submit written notice of rejection within the inspection period. Upon verification of such claim, any funds previously remitted by the Purchaser shall be returned within seven (7) business days.
- 6. Payment of Remaining Balance (if applicable):** If the Purchaser elects to make an initial partial payment toward the total purchase price, the outstanding balance shall be payable only after delivery of the Vehicle and the Purchaser's acceptance thereof pursuant to the inspection and acceptance provisions set forth in this Agreement.
- 7. Release of Funds:** No funds shall be released to the Seller until completion of the inspection period and acceptance of the Vehicle by the Purchaser, thereby ensuring the Purchaser's right to satisfactory inspection prior to finalization of the transaction.
- 8. Transportation Services:** Transportation and delivery services relating to the Vehicle shall be coordinated and carried out by Sure Way Inc pursuant to the terms and conditions agreed upon by the parties.
